A RESOLUTION AUTHORIZING THE CITY OF ATLANTA TO INCLUDE IN ITS 2002 LEGISLATIVE PACKAGE A REQUEST FOR THE GEORGIA STATE LEGISLATURE TO INCREASE THE MONTHLY EMERGENCY 911 (E-911) SURCHARGE OF \$1.50 FOR WIRE TELEPHONE SUBSCRIBERS AND \$1.00 FOR WIRELESS TELEPHONE SUBSCRIBERS TO \$1.92 AND \$1.42 RESPECTIVELY; AND FOR OTHER PURPOSES

WHEREAS, the General Assembly adopted an act which amended the "Georgia Emergency Telephone Number "911" Service Act of 1977 (the "Act"); and

WHEREAS, said act provides a procedure for levying and collecting a monthly "911" charge upon each exchange access facility subscribed to by telephone subscribers whose exchange access lines are in the areas served or which would be served by the "911" Service; and

WHEREAS, said monthly "911" charges shall be used only too pay for the operation and maintenance of the "911" system including necessary equipment acquisitions; and

WHEREAS, section 46-5-134 of the OCGA, established these rates as not to exceed \$1.50 for wire and \$1.00 for wireless subscribers; and

WHEREAS, recent emergency events have resulted in a greater need for public safety in the City; and

WHEREAS, the City of Atlanta feels that the continued maintenance and operation of it's emergency 911 system is in the best interest of the citizens of Atlanta; and

WHEREAS, cost associated with providing this emergency 911 service have outpaced the corresponding revenues derived from "911" rates charged to subscribers; and

WHEREAS, the City of Atlanta wishes to recover these cost by increasing the monthly emergency 911 phone service charge to subscribers from \$1.50 for wire and \$1.00 for wireless subscribers to \$1.92 for wire and \$1.42 for wireless.



**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE
CITY OF ATLANTA, GEORGIA AS FOLLOWS:**

That upon adoption of this legislation it should be placed in the 2002 Legislative Package to express the City of Atlanta's intent to increase the emergency "911" charge to wire and wireless subscribers by Georgia General Assembly amendment to Section 46-5-134 (a)(1) and 2(a)(1) of the O.C.G.A to reflect a change from \$1.50 and \$1.00 to \$1.92 and \$1.42, respectively.
