

AN ORDINANCE

BY COUNCILMEMBER CLAIR MULLER

AN ORDINANCE TO TRANSFER THE AMOUNT OF \$120,000 (ONE HUNDRED, TWENTY THOUSAND DOLLARS) OF THE AMOUNT REMAINING FROM DISTRICT 8 COUNCILMEMBER'S COST CENTER FOR THE CONSTRUCTION/MAINTENANCE OF VARIOUS SIDEWALK PROJECTS (BUT NOT LIMITED TO SIDEWALKS) WITHIN COUNCIL DISTRICT 8; AND FOR OTHER PURPOSES.

WHEREAS, the Department of Planning, Development & Neighborhood Conservation and the Department of Public Works have identified numerous sidewalk projects for construction/repairs within the City's Comprehensive Development Plan and the Quality of Life Improvements Bond Projects; and

WHEREAS, many of the neighborhoods within Council District 8 are desirous of sidewalks, curbing, bulb-outs, speed humps, etc. as a means of calming traffic on residential streets and creating safety for pedestrians; and

WHEREAS, although many of the major streets within District 8 have been selected to receive sidewalks, etc., many will not be chosen due to budgetary limitations; and

WHEREAS, Councilmember Muller is desirous of transferring/contributing \$120,000 (One Hundred and Twenty Thousand Dollars) of the funds remaining within the District 8 Councilmember's Cost Center into a District 8 Trust Fund to be created to receive these funds for construction/maintenance of sidewalks (but not limited to sidewalks; may also include curbing, bulb-outs, speed humps, etc.) within Council District 8 (with locations of various projects to be determined).

NOW, THEREFOR, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That Councilmember Clair Muller is desirous of transferring/contributing \$120,000 (One Hundred and Twenty Thousand Dollars) of the funds remaining within the District 8 Councilmember's Cost Center into a Trust Fund to be created to receive these funds for construction/maintenance of sidewalks (but not limited to sidewalks; may also include curbing, bulb-outs, speed humps, etc.) within Council District 8 (with locations of various projects to be determined).

Section 2: That a District 8 Trust Fund shall be created to receive the \$120,000 transferred/contributed from the District 8 Cost Center, and said transfer should occur from various accounts within District 8 on or before December 31, 2001 year-end budgetary close-out.

Section 3: That the various projects as outlined in Section 1 shall be paid for from the designated Trust Fund Project Center for District 8.

Section 4: That the District 8 Trust Fund shall be established under the auspices of the Department of Public Works so that they may have oversight of the various projects as outlined in Section 1.

Section 5: That the locations of the various projects shall be identified and approved by Councilmember Clair Muller.

Section 6: That all ordinances and parts of ordinances in conflict herewith be and the same are hereby repealed.
