AN ORDINANCE AUTHORIZING OVERTIME PAY IN LIEU OF COMPENSATORY TIME TO ALL SWORN POLICE OFFICERS AT THE RANK OF SARGENT AND BELOW FOR TIME WORKED BETWEEN 160 AND 171 HOURS PER PAY PERIOD (BEGINNING WITH PAY PERIOD \_\_\_\_\_) DUE TO THE NEED FOR HEIGHTENED SECURITY BROUGHT ABOUT BY ACTS OF DOMESTIC TERRORISM AND FOR OTHER PURPOSES.

WHEREAS, a need for heightened security brought about by recent acts of domestic terrorism, has caused the deployment of all City of Atlanta police officers on a mandatory twelve (12) hour shift basis; and

WHEREAS, the applicable ordinance(s) and policy of the City of Atlanta require "non-exempt" city employees to take compensatory time for time worked between 160 and 171 hours per pay period; and

WHEREAS, it is unlikely that police officers who have worked overtime will be able to take compensatory time at any time in the foreseeable future; and

WHEREAS, it is the desire of the City of Atlanta that said officers receive overtime pay for these hours worked in lieu of compensatory time.

**THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS**

**AS FOLLOWS:**

**Section 1:** Overtime pay in lieu of compensatory time is hereby authorized for all sworn police officers at the rank of sargent and below for time worked between 160 and 171 hours per pay period (beginning with pay period \_\_\_\_\_) due to the need for heightened security brought about by acts of domestic terrorism. The overtime pay authorized herein shall be payable at the "straight" time rate.

**Section 2:** All ordinances and parts of ordinances in conflict herewith are hereby waived solely for the purpose set forth herein in this ordinance.
