



**A SUBSTITUTE ORDINANCE
BY PUBLIC SAFETY COMMITTEE**

AN ORDINANCE AMENDING THE 2001 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF POLICE BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF \$232,000 FOR DUI TASK FORCE PROGRAM FUNDED BY THE GOVERNOR'S OFFICE OF HIGHWAY SAFETY TO CONDUCT A REGIONAL DUI ENFORCEMENT PROGRAM, AND FOR OTHER PURPOSES.

WHEREAS, The Governor's Office of Highway Safety has awarded the Atlanta Police Department a grant in the amount of \$232,000 to implement a regional DUI enforcement initiative to be matched 25% in year two from local sources for programs and 50% in year three to enhance public safety in the City of Atlanta; and

WHEREAS, Law Enforcement agencies in surrounding jurisdictions in the Metropolitan Atlanta Area are recipients of similar grants as part of a state plan to implement a region wide enforcement effort against DUI offenses; and

WHEREAS, reduction of DUI offenses in the city is critical to the region wide plan and such enforcement is essential to making the City of Atlanta safer; and

WHEREAS, the Budget Commission of the City of Atlanta, Georgia has recommended increasing estimated receipts in the Intergovernmental Grant Fund by \$232,000;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA AS FOLLOWS:

Section 1: That the 2001 (Intergovernmental Grant Fund) Budget, Department of Police, be and is hereby amended as follows:


