AN ORDINANCE

AN ORDINANCE TO AMEND SECTION 138-128 OF THE CODE OF ORDINANCES OF THE CITY OF ATLANTA SO AS TO PROHIBIT ANY FRANCHISE, ANY ENTITY THAT IS NOT A PARTY TO A CURRENT FRANCHISE AGREEMENT OR REVOCABLE LICENSE AGREEMENT WITH THE CITY OF ATLANTA, OR IS NOT CURRENT IN THE PAYMENT OF ANY FRANCHISE FEES, REVOCABLE LICENSE FEES, OR ANY OTHER FEES IMPOSED PURSUANT TO THIS CHAPTER FROM OBTAINING ANY PERMIT ISSUED BY THE CITY OF ATLANTA; TO REPEAL CONFLICTING ORDINANCES; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta is a multi-billion dollar business; and

WHEREAS, the City Council has a fiduciary responsibility to its citizens and the ratepayers of the City through its policymaking function; and

WHEREAS, it is crucial to the economic health of the City that all fees, taxes and other assessments be paid in a timely manner.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:


Section 1: That Chapter 138, Article IV, Section 138-128 of the Code of Ordinances is hereby amended by adding a new sub-section (f) which shall read as follows:

"(f) No permit shall be issued by the City of Atlanta pursuant to Chapter 138 Code of Ordinances to any entity that is not a party to a current franchise agreement or revocable license agreement with the City of Atlanta, or is not current in the payment of any franchise fees, revocable license fees, or any other fees imposed pursuant to this Chapter."

Section 2: That all ordinances and parts of ordinances in conflict herewith are hereby repealed.
