AN ORDINANCE TO TRANSFER **\$11,000.00** FROM A CITY COUNCIL MEMBER ACCOUNT TO THE DEPARTMENT OF PLANNING, DEVELOPMENT AND NEIGHBORHOOD CONSERVATION TO FUND VARIOUS PROJECTS AS CITED IN THE NORTHWEST ATLANTA FRAMEWORK PLAN, AND FOR OTHER PURPOSES.

WHEREAS, the Council Member from District 9 has funds remaining in her Council budget; and

WHEREAS, the Department of Planning, Development and Neighborhood Conservation along with a large amount of public input has developed the Northwest Atlanta Framework Plan, and

WHEREAS, specific projects have been selected and need to be completed; and

WHEREAS, partial funding has been provided through Community Development Block Grants and the Department of Planning but additional funding is still needed to complete specific projects.

WHEREAS, the Budget Commission of the City of Atlanta anticipates increasing receipts in the Trust Fund.

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:


