AN ORDINANCE TO AMEND THE 2001 (INTERGOVERNMENTAL GRANT FUND) BUDGET DEPARTMENT OF THE MAYOR, BY ADDING TO ANTICIPATIONS, AND APPROPRIATIONS IN THE AMOUNT OF \$588,806 FROM UNITED STATES DEPARTMENT OF JUSTICE EXECUTIVE OFFICE FOR WEED & SEED AND CITY OF ATLANTA MATCHING FUNDS FOR THE CONTINUATION OF THE WEED & SEED STRATEGY IN ATLANTA.

WHEREAS, the Department of Justice, the Bureau of Justice Programs has funded the Weed & Seed strategy for seven consecutive years for the purpose of providing services in designated neighborhoods that eliminate drug activity and create safer neighborhoods, neighborhood vitality, economic development and mobilization resources for seeding programs from a variety of federal, state and local agencies and

WHEREAS, the City of Atlanta has been notified of funding for an additional year, and

WHEREAS, the City of Atlanta wishes to continue and expand this program adding the Pittsburgh community as a targeted site.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA GEORGIA, as follows:

Section 1: That the 2001 (Intergovernmental Grant Fund) Budget, Department of the Mayor, be and is amended hereby as follows:

Section 4: That all ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.



WHEREAS, the Department of Justice, the Bureau of Justice Assistance has funded the Weed and Seed program for the purpose of providing services in designated communities that eliminate drug activity and create safer neighborhoods, neighborhood vitality, economic development and mobilize resources for seeding programs from a variety of federal agencies and;

WHEREAS, the City of Atlanta has been notified of the possibility of funding for an additional year, and;

WHEREAS, the City of Atlanta wishes to continue this program.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

**Section 1:** That the Mayor is hereby authorized to apply for and accept grant funds from Department of Justice, Bureau of Justice Assistance, the Executive Office for Weed and Seed in an amount not to exceed One Hundred Seventy-Five Thousand Dollars (\$175,000.00).

**Section 2:** That the City of Atlanta will provide the local cash match in the amount of Four Hundred and Thirteen Thousand Eight Hundred and Six Dollars (\$413,806.00), to be advanced by the Chief Financial Officer as needed to be taken from 1A01 562001 X41001.

**Section 3:** That the Mayor is authorized to enter into any necessary grant agreements.
