A RESOLUTION REQUESTING THE DIRECTION OF A PERCENTAGE OF FUNDS FROM APPROPRIATIONS FOR CERTAIN RECENT CAPITAL IMPROVEMENT PROJECTS IN THE CITY OF ATLANTA TO THE MUNICIPAL ARTS FUND ACCOUNT; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta passed legislation requiring the expenditure of one percent of public funds devoted to the construction of capital projects for the purpose of funding public works of art; and

WHEREAS, the City of Atlanta is required to direct appropriate levels of funding to the municipal arts fund account whenever funds are appropriated for capital projects; and

WHEREAS, the City of Atlanta has recently appropriated funds for the construction of the Multi-Modal Transportation station, the Atlanta Traffic Court Building, the Airport Runway Extension and other related projects, two new Natatorium complexes; and

WHEREAS the citizens of Atlanta have recently approved the expenditure of \$150 million dollars in capital projects related to creating an improved pedestrian environment.

THEREFORE, BE IT HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the Chief Financial Officer provide the Finance/Executive Committee with legislation directing the appropriate level of funds from monies appropriated for the Multi-Modal Transportation Station, the Atlanta Traffic Court Building, the Airport Runway Extension and other related projects at Hartsfield Atlanta International Airport, the two new Natatorium complexes and the recent pedestrian improvements bond referendum to the municipal arts fund account in compliance with Section 46-76 through 46-81 of the Atlanta Code of Ordinances.

SECTION 2: That the Chief Financial Officer report to the Finance/Executive Committee any obligation on the part of GADOT and Atlanta Station LLC to participate in the municipal arts fund as a result of the construction of the Seventeenth Street Bridge.

SECTION 3: That the Bureau of Cultural Affairs prepare a plan for public and Council input relative to the appropriate expenditure of said funds for the municipal arts plan.

SECTION 4: That the Council and appropriate staff be reminded of the existence of Section 46-76 through 46-81, and that future appropriations for capital projects routinely direct funds to the municipal arts fund account in order to maintain our commitment to public works of art in the City of Atlanta.
