A RESOLUTION TO REQUEST THE DEPARTMENT OF PUBLIC WORKS TO PROCEED WITH THE INSTALLATION OF SIDEWALKS ON HAVENRIDGE DRIVE, NW; AND FOR OTHER PURPOSES.

WHEREAS, It is in the public interest to expeditiously install sidewalks in high pedestrian traffic areas in residential neighborhoods; and

WHEREAS, foot traffic as well as commercial vehicular traffic in the Bobby Jones Golf Course area has increased substantially within the last 5 years; and

WHEREAS, Havenridge Drive, NW has become a "cut-through" area, and that part of Havenridge between Peachtree Battle and Woodward Way is uncommonly busy and the neighborhood has requested sidewalks for several years and is currently on an installation list in the Department of Public Works.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES as follows:

SECTION 1. That the Department of Public Works is requested to proceed with installation of sidewalks on Havenridge Drive, NW, 30305, between Peachtree Battle and Woodward Way.

SECTION 1. That the Department of Public Works, assisted by the Department of Finance, is requested to research the funding of this sidewalk, as it has been on the Department of Public Work's list of sidewalk installation for several years.

SECTION 1. All resolutions or parts of resolutions in conflict herewith are hereby repealed.
