A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE APPROVE A NOTICE TO PROCEED FOR HDR/WL JORDEN, INC.; FOR FC 6710-97; ANNUAL CONTRACT FOR ARCHITECTURAL AND ENGINEERING SERVICES TO PROVIDE A COMBINED SEWER EVALUATION AND CONCEPTUAL DESIGN OF SEWER SEPARATION; IN AN AMOUNT NOT TO EXCEED ONE MILLION TWO HUNDRED SEVENTY SEVEN THOUSAND FIVE HUNDRED DOLLARS AND NO CENTS (\$1,277,500.00); ALL CONTRACTED WORK SHALL BE CHARGED TO AND PAID FROM FUND, ACCOUNT, CENTER NUMBER 2J26-524001-M56I21049999 and 2J26-524001-M56I21019999; AND FOR OTHER PURPOSES.

WHEREAS, the City did enter into agreement with HDR/WL Jorden, Inc., for FC 6710-97, Annual Contract for Architectural and Engineering Services; and

WHEREAS, this resolution authorizes HDR/WL Jorden, Inc. to begin on Phase I of a two phase study totaling Five Million Eight Hundred Ten Thousand Dollars And No Cents (\$5,810,000.00); and

WHEREAS, funding from the 2002 Water and Sewer Bond will have to be used to fund Phase II of this study totaling Four Million Five Hundred Thirty Two Thousand Five Hundred Dollars and No Cents (\$4,532,500.00); and

WHEREAS, the Department of Public Works does require the update of GIS sewer, parcel, and land use coverages with data from manhole inspection surveys, GPS locations, closed circuit television surveys, and sewer trunk line surveys; and

WHEREAS, the Department of Public Works does require a conceptual sewer separation plan; and

WHEREAS, the Commissioner of the Department of Public Works and the Director of the Bureau of Purchasing and Real Estate have recommended that HDR/WL Jorden, Inc. provide these services to the City of Atlanta; and

NOW, THEREFORE, BE AND IT IS RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, that the Mayor be and is hereby authorized to approve a Notice to Proceed with HDR/WL Jorden, Inc. for FC 6710-97, for Combined Sewer Evaluation




and Conceptual Design of Sewer Separation in an amount not to exceed One Million Two Hundred Seventy Seven Thousand Five Hundred Dollars And No Cents (\$1,277,500.00);

BE IT FURTHER RESOLVED, that the Director of the Bureau of Purchasing and Real Estate be and is hereby directed to prepare an appropriate contractual agreement to be approved by the City Attorney, as to form for execution by the Mayor.

BE IT FURTHER RESOLVED, that this Notice to Proceed shall not become binding on the City, and the City shall incur no liability upon same until such contract has been executed by the Mayor and delivered to the contracting party.

BE IT FURTHER RESOLVED, that all services for said contracted work shall be charged to and paid from Fund, Account, and Center Number: 2J26-524001-M56I21049999 and 2J26-524001-M56I21019999.
