A RESOLUTION AUTHORIZING THE MAYOR OR HER DESIGNEE TO EXECUTE AN AIRPORT USE LICENSE AGREEMENT WITH COMAIR, INC., COVERING THE USE OF RUNWAYS, TAXIWAYS, AND OTHER COMMON AIRFIELD FACILITIES AT HARTSFIELD ATLANTA INTERNATIONAL AIRPORT; AND FOR OTHER PURPOSES.

WHEREAS, Comair, Inc., intends to provide regularly scheduled airline service to and from Hartsfield Atlanta International Airport; and

WHEREAS, Comair, Inc., desires to enter into an Airport Use License Agreement with the City of Atlanta as a domestic carrier serving the Airport; and

WHEREAS, it is in the best interest of the Airport and the City to enter into an Airport Use License Agreement with Comair, Inc., as hereinafter set forth.


NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor or her designee be and hereby is authorized to execute on behalf of the City of Atlanta an Airport Use License Agreement with Comair, Inc., which shall contain the following terms, conditions, and provisions:

- 1) a term effective as of November 1, 2001, and ending October 31, 2006; and
- 2) landing fee rates to be computed in the manner set forth in the airport use agreement; and
- 3) a landing fee to be computed at the initial rate of \$0.39797 per 1,000 pounds of the FAA Maximum Certificated Gross Landing Weight of each aircraft scheduled to land at the Airport, which rate shall be subject to adjustment from time to time at the discretion of the City acting through its Aviation General Manager; and
- 4) such other terms, conditions, and provisions as may be required by City ordinances or Federal regulations or as are customarily included in Airport Use License Agreements at the Airport.

BE IT FURTHER RESOLVED that the City Attorney be and hereby is directed to prepare said Use License Agreement for execution by the Mayor or her designee, with same to be approved as to form by the City Attorney.

BE IT FINALLY RESOLVED that said Use License Agreement shall not become binding upon the City of Atlanta, and the City of Atlanta shall incur no obligation nor liability thereunder until the same has been signed by the Mayor or her designee and delivered to Comair, Inc.
