AN ORDINANCE TO AMEND CHAPTER 10 AND APPENDIX B OF THE CITY OF ATLANTA CODE OF ORDINANCES TO DELETE EXISTING FEES PERTAINING TO CERTAIN TYPES OF ALCOHOLIC BEVERAGE LICENSES; AND TO INCREASE EXISTING FEES PERTAINING TO CERTAIN TYPES OF ALCOHOLIC BEVERAGE LICENSES.

WHEREAS, the City of Atlanta has an interest in maintaining the public health, safety and welfare; and

WHEREAS, pursuant to its powers, the City of Atlanta is authorized to enact legislation to regulate certain types of businesses and industries which could potentially affect the public health, safety and welfare, including businesses which involve the manufacture, distribution, or sale of alcoholic beverages; and

WHEREAS, the City of Atlanta is authorized to issue licenses to businesses involved in the manufacture, distribution, or sale of alcoholic beverages and to establish fees which correlate with the costs incurred by the City in performing investigations, regulation, and enforcement of laws pertaining to such businesses; and

WHEREAS, in November, 1998, the City Council adopted and the Mayor approved legislation which increased the fees which are associated with the issuance of licenses to manufacture, distribute, or sell alcoholic beverages in the City of Atlanta; and

WHEREAS, the increased fees contained in such legislation are based on the actual costs incurred by the City of Atlanta in continual investigation, regulation and enforcement of laws pertaining to such businesses; and

WHEREAS, although the increased fees are directly related to the costs incurred by the City of Atlanta, the City desires to allow such costs to be recouped without causing a severe hardship on the businesses affected by the increase; and

WHEREAS, the City is currently authorized to charge an annual license fee up to the amount of \$5,000 for each alcoholic beverage license issued; and

WHEREAS, none of the fees set forth herein will be increased to the maximum allowed amount of \$5,000; and

Now, therefore, Be it ordained by the Council of the City of Atlanta, Georgia as follows:

Section 1. That Chapter 10; Section 10-60 of the City of Atlanta Code of Ordinances is hereby amended by deleting the existing language contained in such section and inserting in lieu thereof new language so that such section shall read as follows:




Section 10-60 Annual License fee; refunds.

a) The annual license fee for each classification of license under this division shall be as follows:

<i>1) Wine.</i>	<u>Fee Effective For Year 2002</u>
c. Retail dealer in wine to be consumed on or off the premises of the dealer...	\$2,362.50
d. Retail dealer in wine to be consumed off the premises of the dealer only...	\$1,575.00
<i>1) Malt Beverages.</i>	
c. Retail dealer of beer to be consumed on or off the premises of the dealer...	\$2,362.50
d. Retail dealer in beer to be consumed off the premises of the dealer only...	\$1,575.00

Section 2. That the provisions of this ordinance shall become effective December 31, 2002.

Section 3. That all ordinances or parts thereof in conflict with this ordinance are hereby repealed.
