A RESOLUTION REQUESTING A STUDY OF THE WEST  
PACES FERRY ROAD CORRIDOR AND FOR OTHER  
PURPOSES.

WHEREAS it is in the public interest that a study be undertaken to analyze and to plan  
for the future of West Paces Ferry Road, and

WHEREAS said study must investigate *and protect* the existing land use pattern along  
West Paces Ferry Road, including housing resources, historic resources, traffic,  
sidewalk design and other pedestrian amenities, and tree protection,


NOW THEREFORE BE AND IT IS HEREBY RESOLVED BY THE COUNCIL OF  
THE CITY OF ATLANTA, AS FOLLOWS:

Section 1. That the Commissioner of the Department of Planning, Development,  
and Neighborhood Conservation and the Commissioner of the Department of Public  
Works shall cause to be undertaken a study of the West Paces Ferry Road corridor from  
the Buckhead Village on the east to Interstate 75 on the west.

Section 2. That said study and plan shall include an analysis of housing  
resources, historic resources, traffic, sidewalk design and other pedestrian amenities, and  
tree protection.

Section 3. That the Commissioner of the Department of Planning, Development,  
and Neighborhood Conservation and the Commissioner of the Department of Public  
Works shall provide a report on this planning effort to the Community Development and  
Human Resources Committee of Council on a monthly basis and said study shall be  
completed within six months of adoption of this resolution.
