WHEREAS, the City of Atlanta, in 2002, is faced a severe shortfall in its budget; and

WHEREAS, it is imperative that the City has sufficient revenue to provide services for its citizens; and

WHEREAS, there should be alternative revenue sources other than property taxes; and

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA that there is hereby created a Committee to study the feasibility of placing a surcharge on all parking fees in the City of Atlanta.

BE IT FURTHER RESOLVED THAT the Committee shall consist of the Chief Financial Officer (or his designee), the Manager of the Bureau of Traffic and Transportation, the chair of the Atlanta Planning and Advisory Board and a representative from the Parking Industry, to be appointed by the Chair of the Transportation Committee. Said Committee shall be convened by the Chief Financial Officer.

BE IT FINALLY RESOLVED that the Committee make a report to the Finance/Executive Committee no later than July 1, 2002.
