COMMUNITY DEVELOPMENT/HUMAN RESOURCES COMMITTEE**

AN ORDINANCE AMENDING THE 2002 (COMMUNITY DEVELOPMENT FUND) BY ANTICIPATING AND APPROPRIATING \$1,920,250.00, 2002 (HOME INVESTMENT FUND) BY ANTICIPATING AND APPROPRIATING \$406,400.00, AND 2002 (INTERGOVERNMENTAL GRANT FUND) BUDGET BY ANTICIPATING AND APPROPRIATING \$116,520.00 AND TRANSFERRING APPROPRIATIONS FROM RESERVE ACCOUNTS TO ADMINISTRATIVE ACCOUNTS IN THE 2002 CDBG, HOME, AND HOPWA PROGRAMS; AND FOR OTHER PURPOSES.

WHEREAS, the City Council adopted on November 5, 2001 and the Mayor approved on November 13, 2001, projects and program administration to be included in the 2002 Community Development Block Grant (CDBG), 2002 Home Investment Partnership Grant (HOME), and 2002 Housing Opportunities for Persons with AIDS (HOPWA) Programs; and

WHEREAS, the administrative projects included in the 2002 CDBG program are:

- CD-02-07, Housing Rehabilitation Administration
- CD-02-55, Housing Code Inspection

WHEREAS, the Budget Commission of the City of Atlanta has recommended increasing estimated receipts in the 2002 (Community Development Fund) Budget by \$1,920,250.00, the 2002 (HOME Investment Trust Fund) Budget by \$406,400.00, and in the 2002 (Intergovernmental Grant Fund) Budget by \$116,520.00.
