AN ORDINANCE AMENDING SECTION 2-2, ARTICLE I, CHAPTER 2, PART II OF THE CITY CODE OF ORDINANCES, TO PROVIDE THAT THE CITY COUNCIL SHALL NOT ADOPT ANY ORDINANCE OR RESOLUTION FOR THE PURPOSE OF NAMING ANY PUBLIC FACILITY OR STREET IN HONOR OF PERSON UNLESS IT IS PLACED ON ONE AGENDA OF THE AFFECTED NEIGHBORHOOD PLANNING UNIT(S), FOR INFORMATIONAL PURPOSES ONLY; TO REPEAL CONFLICTING ORDINANCES; AND FOR OTHER PURPOSES.

THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA,
HEREBY ORDAINS as follows:

SECTION 1: That Sec. 2-2, Article I, Chapter 2, Part II of the City Code of Ordinances, is amended with an additional paragraph so that the new Sec. 2-2 shall read:

"Sec. 2-2. Naming of public facilities and streets in honor of persons.

No public building, park, park facility, public street, right-of-way, bridge or similar public facility shall be named after or in honor of any person, unless such person has attained the age of 75 years or has been deceased at least 30 days or such naming is a condition of a gift or grant accepted by the city.

The City Council shall not adopt any ordinance or resolution for the purpose of such naming unless it is placed on one agenda of the affected neighborhood planning unit(s), for informational purposes.

SECTION 2: That all ordinances and parts of ordinance in conflict herewith are hereby repealed.
