BIOGRAPHY

Arnold P. Silverman

Arnold P. Silverman attended Stevens Institute of Technology in Hoboken, New Jersey, and received a Bachelors of Engineering degree in 1970. In 1973, Arnie went back to school for a Masters in Business Administration which he received in 1974 from Columbia University in New York.

In 1979, Arnie moved to Atlanta and with his brother, Robert L. Silverman, purchased the old A. R. Winter Company, a small commercial construction company. In 1995, Arnie sold his interest in The Winter Construction Company and after taking a few months off to spend time with his family, he founded Silverman|Construction Program Management ("Silverman"). Silverman has committed that a minimum of 50% of its revenues will be from working with non-profit organizations at reduced rates. Thus far, in his firm's young history, it has exceeded Arnie's commitment.

Arnie has been personally involved in Silverman's "green space" projects, including the rehabilitation of Olmsted Linear Park - Phase I (primarily Oak Grove Park), fundraising and program planning for Olmsted Linear Park - Phase II (Virgilee, Dellwood, and Shadyside Parks), as well as several Freedom Park projects including the North/South leg, Moreland Gateway, Moreland-Highland Connector, John Lewis Plaza, and the West Segment of Freedom Park.
