

A SUBSTITUTE ORDINANCE BY;

AN ORDINANCE TO TRANSFER THE AMOUNT OF \$7,500 FROM DISTRICT SEVEN (7) COUNCIL MEMBER EXPENSE ACCOUNT TO THE INSURANCE ACCOUNT FOR THE GARDEN HILLS PARK SWIMMING POOL FOR THE EXPRESS PURPOSE OF DEFRAYING THE ADDITIONAL INSURANCE EXPENSES; AND FOR OTHER PURPOSES.

**WHEREAS**, the Garden Hills Pool and Park Association, Inc. leased the Garden Hills Swimming Pool and Recreation Center from the City of Atlanta for the past several years; and

**WHEREAS**, the lease was successful and beneficial to both parties; and

**WHEREAS**, the Association and the City of Atlanta Department of Parks, Recreation and Cultural Affairs desire to continue the on-going lease arrangement; and

**WHEREAS**, the recent insurance rate hike has adversely affected the financial condition of the Garden Hills Pool and Park Association, Inc., which is in need of financial assistance.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, as follows:

**Section 1:** That the 2002 (General Fund) Budget be and is hereby amended as follows:
