WHEREAS, the Garden Hills Pool and Park Association (GHPPA) has operated the pool under lease from the City of Atlanta for several years, which has been recently renewed for another term; and

WHEREAS, improvements to the bathhouse and the pool must be made in order to meet the requirements of the Fulton County Health Department for the opening of the pool.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Purchasing Agent is hereby authorized to execute a Purchase Order with Garden Hills Pool and Park Association in an amount not to exceed \$135,000.00

BE IT FURTHER RESOLVED, that the Purchasing Agent be and is hereby directed to execute a purchase order.

BE IT FURTHER RESOLVED, that said purchase order shall not become binding on the City and the City shall incur no liability upon same until such purchase order has been executed by the Purchasing Agent and delivered to the contracting parties.
