



**AN ORDINANCE
BY COMMITTEE ON COUNCIL**

**AN ORDINANCE TO AMEND THE 2001 CITY OF ATLANTA
PRECINCT AND POLLING PLACE ORDINANCE IN PRECINCT
12S AND 7G AND FOR OTHER PURPOSES**

WHEREAS, the 2001 Precinct and Polling Place Ordinance was adopted November 5, 2001, and Approved November 13, 2001, and;

WHEREAS, the Fulton County Board of Registrations and Elections has authorized and approved various precinct polling place changes within the City of Atlanta due to renovations of certain schools and;

WHEREAS, those changes are to precincts/polling places **12S & 7G**;

WHEREAS, the governing authority of the City of Atlanta, the Atlanta City Council believes that ratification of these previously authorized changes should be made by this Body.

NOW THEREFORE BE IT ORDAINED that the Atlanta City Council does hereby Amend the 2001 Precinct and Polling Places Adopted November 5, 2001, and Approved November 13, 2001, as required by Section 66-2 of the City of Atlanta Code of Ordinances and Section 21-2-261 (a) of the Georgia Election Code and Rules of the State Election Board and as described by the attachments which are made a part hereof and identified as Exhibits A and B.

BE IT FURTHER ORDAINED that the Atlanta City Council does hereby ratify the previous authorization and approval by the Fulton County Board of Registrations and Elections of precincts and polling places within the City of Atlanta as follows:

SECTION 1. Amend Precinct/Polling Place **12S**, currently located at Slater Elementary School, 1320 Pryor Road, SW by *temporarily relocating* 12S to Arthur Langford Recreational Center, 1614 Joyland Place, SE as indicated by attachment identified as *Exhibit A*.

SECTION 2. Amend Precinct/Polling Place **7G** located at Garden Hills School, 285 Sheridan Dr., NE by *temporarily relocating* 7G to the Atlanta International School, 2890 North Fulton Dr., NE., as indicated by attachment identified as *Exhibit B*.

SECTION 3. That all ordinances and parts of ordinances in conflict herewith are hereby repealed.




