

AN ORDINANCE BY COUNCIL MEMBER FELCIA A MOORE AS SUBSTITUTED  
BY FINANCE EXECUTIVE COMMITTEE

AMENDING THE 2002 GENERAL FUND BUDGET AND THE 2002 TRUST FUND BUDGET BY TRANSFERRING APPROPRIATIONS FROM THE DEPARTMENT OF PARKS, RECREATION AND CULTURAL AFFAIRS TO THE EXECUTIVE OFFICES TO CORRECT APPROPRIATIONS CONTAINED IN THE BUDGET ORDINANCE ADOPTED ON FEBRUARY 25<sup>TH</sup> SO AS TO RETURN THE OFFICE OF COMMUNITY AFFAIRS, WITH THE EXCEPTION OF THE NEIGHBORHOOD CENTERS AND YOUTH SERVICES, TO THE EXECUTIVE OFFICES, AND FOR OTHER PURPOSES

WHEREAS, the General Fund budget for the entire Office of Community Affairs was transferred to the Department of Parks, Recreation, and Cultural Affairs from the Executive Offices in the 2002 Budget, and

WHEREAS, the neighborhood centers and youth services were to be transferred to the Department of Parks, Recreation, and Cultural Affairs, and

WHEREAS, the General Fund Budget for the Office of Community Affairs, with the exception of the neighborhood centers and youth services, needs to be transferred back to the Executive Offices, and

WHEREAS, there are appropriations in various Trust Fund accounts that need to be transferred from the Executive Offices to the Department of Parks, Recreation and Cultural Affairs to reflect the transfer of Youth Services.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF ATLANTA GEORGIA, as follows:

SECTION 1: That the 2002 (General Fund) Budget be and is hereby amended as follows:


