A RESOLUTION AUTHORIZING THE MAYOR OR DESIGNEE TO ISSUE A NOTICE TO PROCEED WITH MAYES, SUDDERTH & ETHEREDGE, INC./HARRINGTON, GEORGE & DUNN, PC - JV FOR FC-6710-96B, ANNUAL CONTRACT FOR ARCHITECTURAL AND ENGINEERING SERVICES TO PROVIDE COMBINED SEWER EVALUATION AND CONCEPTUAL DESIGN OF SEWER SEPARATIONS ON BEHALF OF THE DEPARTMENT OF PUBLIC WORKS IN AN AMOUNT NOT TO EXCEED SIX MILLION SEVEN HUNDRED SEVENTY-SEVEN THOUSAND FIVE HUNDRED DOLLARS (\$6,777,500.00); AND TO RESCIND RESOLUTION 01-R-2034 FOR THE INITIAL PHASE DUE TO THE WRONG ANNUAL CONTRACTOR BEING LISTED IN THE RESOLUTION; ALL CONTRACTED WORK SHALL BE CHARGED TO AND PAID FROM FUND ACCOUNT AND CENTER NUMBERS: 2J26 524001 M56I21049999 (\$566,350.00), 2J26 524001 M56I21019999 (\$711,150.00), 2J27 574001 M24I02679999 (\$2,750,000.00), AND 2J27 574001 M24I02689999 (\$2,750,000.00).

**WHEREAS**, the City of Atlanta did enter into FC-6710-96B, Annual Contract for Architectural and Engineering Services; and

**WHEREAS**, the Department of Public Works does require a combined sewer evaluation and conceptual design of sewer separation in an amount not to exceed Six Million Seven Hundred Seventy-seven Thousand Five Hundred Dollars (\$6,777,500.00); and

**WHEREAS**, the Commissioner of the Department of Public Works and the Director of the Bureau of Purchasing and Real Estate have recommended that Mayes, Sudderth & Etheredge, Inc./Harrington, George & Dunn, PC - JV, to develop more reliable conceptual designs and cost estimates for the separation of sanitary flows and treatment of storm flows within existing City of Atlanta Combined Sewer Service Areas; and

**WHEREAS**, Resolution 01-R-2034 for the initial phase of this project adopted by Council on 12/3/01 and approved by the Mayor on 12/11/01 shall be rescinded due to the wrong annual contractor being listed in the resolution. The total fee of \$6,777,500.00 included the previously approved \$1,277,500.000 (01-R-2034); and

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, that the Mayor be and is hereby authorized to approved Notice To Proceed with Mayes, Sudderth & Etheredge, Inc./Harrington, George & Dunn, PC - JV, for FC-6710-96B, Annual Contract for Architectural and Engineering Services in an amount not to exceed Six Million Seven Hundred Seventy-seven Thousand Five Hundred Dollars (\$6,777,500.00).

**BE IT FURTHER RESOLVED**, that the Director of Purchasing be and is hereby directed to prepare an appropriate contractual agreement for execution by the Mayor, to be approved by the City Attorney as to form.



**BE IT FURTHER RESOLVED**, that this Notice to Proceed should not become binding on the City, and the City shall incur no liability upon same until such contract has been executed by the Mayor and delivered to the contracting party.

**BE IT FINALLY RESOLVED**, that all services for said Notice to Proceed shall be charged to and paid from fund account and center numbers: 2J26 524001 M56I21049999 (\$566,350.00), 2J26 524001 M56I21019999 (\$711,150.00), 2J27 574001 M24I02679999 (\$2,750,000.00) and 2J27 574001 M24I02689999 (\$2,750,000.00).
