

**AN ORDINANCE**

**AN ORDINANCE TO ADD THE CODE OF ETHICS AS PART OF THE OATH OF OFFICE FOR ALL OFFICIALS OF THE CITY OF ATLANTA; TO REPEAL CONFLICTING ORDINANCES; AND FOR OTHER PURPOSES.**

**NOW, THEREFORE, BE AND IT IS HEREBY ORDAINED BY THE COUNCIL OF ATLANTA, GEORGIA, as follows:**

**SECTION 1.** That a new sentence is added to the official oath to be assumed by all officials required by law, except the mayor and members of the council, in Section 2-781 (entitled "Official Oath")(Exhibit "A"), Chapter 2, Article VII, Division 1, of the Code of Ordinances of the City of Atlanta, Georgia, to read:

**"I further swear that I will uphold and support the Ethics Code of the City of Atlanta."**


**SECTION 2.** That the amend official oath shall read:

**SECTION 3.** That all ordinances or parts of ordinances in conflict herewith are hereby rescinded.


