AN ORDINANCE AMENDING SECTION 2-824 OF
THE CODE OF ORDINANCE SO AS TO EXTEND
THE EFFECTIVE DATE TO CONSTITUTE THE
NEW ETHICS BOARD PURSUANT TO THE NEW
ETHICS CODE, AND FOR OTHER PURPOSES.

WHEREAS, the new Ethics Code became effective by operation of
law on June 9, 2002; and

WHEREAS, the new Ethics Code required the selection of members
for a new Ethics Board and training sessions on financial disclosure
prior to the effective date of June 9, 2002; and

WHEREAS, although training sessions were held as required, more
time is needed for the selection process for new Ethics Board
members and for additional training sessions.

WHEREAS, the members of the Ethics Board constituted under the
prior Ethics Code have consented to continue their service until a
new Ethics Board is constituted;

NOW THEREFORE IT IS ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA,
GEORGIA,


Section 1. That Section 2-824 is hereby repealed and a new
Section 2-824 is enacted to read as follows:

Section 2-824: Effective Date and Interim Provisions. The
Ethics Board members serving on June 8, 2002 are authorized to
remain office and to administer the Ethics Code until August 5,

2002, or such other time as the new Ethics Board is constituted.

Section 3. That all ordinances and parts of ordinances in conflict herewith are hereby repealed.
