



**A SUBSTITUTE ORDINANCE**

**BY COMMUNITY DEVELOPMENT/HUMAN RESOURCES COMMITTEE**

**AN ORDINANCE ANTICIPATING AND APPROPRIATING \$1,842,500.00 FOR THE SUMMER FOOD SERVICE PROGRAM FOR THE PERIOD DECEMBER 1, 2001 THROUGH NOVEMBER 30, 2002; AND FOR OTHER PURPOSES.**

**WHEREAS**, the State of Georgia's Office of School Readiness has notified the City of Atlanta of the availability of funding for the Summer Food Service Program for Children in an amount not to exceed \$1,842,500.00 for the period December 1, 2001 through November 30, 2002; and

**WHEREAS**, for administrative purposes, it is expedient to anticipate and to appropriate this Grant Funding prior to the receipt of the grant award on the premise that, if and when there has been notification that the grant will not be awarded, all activities associated with this grant program will and any costs incurred prior to defunding will be borne by the General Fund; and

**WHEREAS**, the Budget Commission of the City of Atlanta, Georgia has recommended increasing estimated receipts in the Intergovernmental Grant Fund by \$1,842,500.00.

**NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, AS FOLLOWS:**

**Section 1:** That the 2002 (Intergovernmental Grant Fund) Budget, Bureau of Human Services be and is amended hereby as follows:
