**AMENDING CHAPTER 38, CEMETERIES, OF THE CODE OF ORDINANCES, ARTICLE II, MUNICIPAL CEMETRIES, DIVISION 2. OAKLAND CEMETERY, SECTION 38-44, SCHEDULE OF CHARGES FOR CEMETERY SERVICES AND SECTION 38-45, SCHEDULE OF CHARGES FOR GUIDED TOURS, SPECIFICALLY TO REFLECT NEWLY REVISED, INCREASED FEE SCHEDULES FOR THE DEPARTMENT OF PARKS, RECREATION AND CULTURAL AFFAIRS, BUREAU OF PARKS BY INCREASING/CREATING FEES UNDER SECTION 38-44, FOR INTERNMENT-OPENING AND CLOSING, DISINTERMENT-OPENING AND CLOSING, CREMATION SPACE, INFANT/CHILDREN-OPENING AND CLOSING, AND DISINTERMENT OF CREMAINS; AND TO CREATE VAULT INSTALLATION FEE; CREATE A MARKER INSTALLATION FEE; AND TO CREATE A CHARGE FOR THE USE OF TENTS AND CHAIRS FEE; UNDER SECTION 38-45; TO INCREASE THE STUDENTS (AGES 7-22) RATE TO \$3.00, BY CHARGING THE SENIOR CITIZEN (AGE 65 AND ABOVE) RATE OF \$2.00, BY INCREASING THE ADULT (AGES 23-54) RATE TO \$5.00, AND BY CHARGING THE ADULT (AGES 55-64) RATE OF \$3.00, ON BEHALF OF THE DEPARTMENT OF PARKS, RECREATION AND CULTURAL AFFAIRS, BUREAU OF PARKS; AND FOR OTHER PURPOSES.**

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:**

**Section 1: That Chapter 38, Cemeteries, Section 38-44, Schedule of Charges for Cemetery Services be and is hereby amended by revising the fee schedule for the Department of Parks, Recreation and Cultural Affairs, Bureau of Parks by increasing the Internment-Opening and Closing Fee to \$800.00/Weekday, \$1,000.00/Weekend and \$1,250.00/Holiday; Disinterment-Opening and Closing Fee to \$700.00/Weekday and \$800.00/Weekend; Cremation Space Fee to \$600.00/Weekday, \$600.00/Weekend; Infant/Children-Opening and Closing Fee to \$650.00/Weekday, \$750.00/Weekend, \$750.00/Holiday; Disinterment of Cremains to \$300.00/Weekday, \$400.00/Weekend; and to create a Vault Installation Fee of \$250.00; to create a Marker Installation Fee of \$100.00; to create a Charge for the use of Tents and Chairs of \$100.00.**

**Section 2: That Chapter 38, Cemeteries, Section 38-45, Schedule for Guided Tours be and is hereby amended by revising the fee schedule by increasing the Student (Ages 7-22) Rate to \$3.00, by increasing the Adult (Ages 23 -54) Rate to \$5.00, charging the Adult (ages 55-64) rate of \$3.00; and by charging the Senior Citizens (Ages 65 and above) the rate of \$2.00;**



**Section 3:** That all revenues derived from these increased and created fees at the Oakland Cemetery will be depositing the net increase into the Trust Fund Account Number 3P02 444106 N25D16999999 and expended from Trust Fund Account Numbers 3P02 523001 N25D16999999 and 3P02 575001 N25D16999999.

**Section 4:** That **Chapter 38, Cemeteries**, of the Code of Ordinances shall remain in full force and effect, except as herein amended by these newly established increased fees and fee creations.

**Section 5:** That all Ordinances and parts of Ordinances in conflict herewith be and the same are hereby repealed.


