A SUBSTITUTUE ORDINANCE

BY FINANCE/EXECUTIVE COMMITTEE

A SUBSTITUTE ORDINANCE TO AUTHORIZE THE PAYMENT OF SELECT EXEMPT EMPLOYEES FOR ACCRUED COMPENSATORY TIME ON A ONE-TIME BASIS USING A REIMBURSEMENT GRANT AWARDED TO THE CITY OF ATLANTA'S HARTSFIELD INTERNATIONAL AIRPORT BY THE FEDERAL AVIATION ADMINISTRATION IN THE AMOUNT OF \$7,037,180.00 FOR SECURITY RELATED EXPENSES AS A RESULT OF THE EVENTS OF SEPTEMBER 11, 2001; ALL PAYMENTS SHALL BE CHARGED TO AND PAID FROM FUND ACCOUNT AND CENTER NUMBER 2H21 711008 R21E0904AZ52.

**WHEREAS**, workloads for City of Atlanta, Department of Aviation employees has significantly increased because of mandatory compliance requirements of the Federal Aviation Administration (FAA), and the Transportation Security Administration (TSA) as a result of the September 11, 2001 "Attack on America;" and

**WHEREAS**, City of Atlanta, Department of Aviation, Atlanta Police Department and Atlanta Fire Department employees assigned to the Department of Aviation have been required to work extraordinary hours of overtime and have been required to cancel scheduled off-days and holidays, which has resulted in the accrual of compensatory time that may not be utilized before December 31, 2002 due to increased service demands and security requirements; and

**WHEREAS**, the City of Atlanta Code of Ordinances does not allow for reimbursement of accrued compensatory time for employees in exempt positions; and

**WHEREAS**, the Federal Aviation Administration has awarded the City of Atlanta's Department of Aviation a reimbursement grant in the amount of \$7,037,180.00 to compensate the Airport for a portion of direct costs associated with the events of the September 11, 2001 attack on America; and

**WHEREAS**, these Airport costs and increased employee workloads and hours can be specifically identified as being unique to new, additional, or revised security requirements imposed by the Federal Aviation Administration or the Transportation Security Administration on or after September 11, 2001; and

**WHEREAS**, this one time reimbursement of compensatory time for exemfnt employees is considered a direct cost associated with the events of September 11, 2001 and is permitted to be covered under this grant award at no cost to the City of Atlanta and will allow the City's employees to be compensated for the extended work schedules; and

**WHEREAS**, the City of Atlanta and the Department of Aviation value its employees and desires that they be appropriately compensated for all services rendered during this most devastating time.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, AS FOLLOWS:

SECTION ONE: The City of Atlanta, Department of Aviation, Atlanta Police Department and Atlanta Fire Department exempt employees assigned to the Airport shall be authorized to be paid for compensatory time from September 11, 2001 through September 30, 2002 from a reimbursement grant in the amount of \$7,037,180.00 awarded by the Federal Aviation Administration. All payments shall be charged to and paid from Fund Account and Center Number 2H21 711008 R21E0904AZ52.

SECTION TWO: All accrual and payment of compensatory time shall be documented, monitored and approved by appointing authorities. Compensation will be made to employees no later than December 31, 2002.

SECTION THREE: The Director Human Resources shall confer with the Aviation General Manager and Chief Financial Officer to prepare the necessary documentation for payment of the select exempt employees.

SECTION FOUR: All ordinances or parts of ordinances in conflict herewith are hereby repealed.
