AN ORDINANCE AMENDING THE 2002 (INTERGOVERNMENTAL GRANT FUND) BUDGET DEPARTMENT OF THE MAYOR, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF \$23,973.00 FROM THE GOVERNOR'S OFFICE OF COMMUNITY AFFAIRS EMERGENCY FUND GRANT FOR THE CITY OF ATLANTA MAYOR'S OFFICE OF CONSTITUENT SERVICES TO ASSIST WITH PROGRAM EXPENSES FOR SOFTWARE UPGRADES AND LICENSING; TO AUTHORIZE THE MAYOR TO SIGN ALL NECESSARY GRANT AGREEMENTS; AND FOR OTHER PURPOSES.


WHEREAS, the City of Atlanta has received a \$23,973.00 State of Georgia Emergency Fund Grant for the purpose of providing funds to the City of Atlanta Mayor's Office of Constituent Services to assist with program expenses for software upgrades and licensing.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That the 2002 (Intergovernmental Grant Fund) Budget, Department of the Mayor, be and is amended hereby as follows:

Section 3: That the City Attorney be and is directed hereby to prepare the appropriate contractual agreements for execution by the Mayor, to be approved by the City Attorney as to form and that said contractual agreements shall not become binding on the City; The City shall incur no liability upon same until such contract has been executed by the Mayor and delivered to the contracting parties.

Section 4: That all ordinances and parts of ordinances in conflict herewith are hereby repealed.
