**A RESOLUTION AUTHORIZING THE MAYOR OF HER DESIGNEE TO ENTER INTO AN AGREEMENT WITH NORFOLK SOUTHERN CORPORATION FOR THE PURPOSE OF OBTAINING ACCEPTABLE ENGINEERING AND CONSTRUCTION DOCUMENTS FOR REPLACEMENT OF ROXBORO ROAD UNDERPASS ON BEHALF OF THE DEPARTMENT OF PUBLIC WORKS, IN AN AMOUNT NOT TO EXCEED \$204,434.00. ALL CONTRACTED WORK SHALL BE CHARGED TO AND PAID FROM FUND, ACCOUNT AND CENTER NUMBER: 1C28 574001 M22F012992BA.**

**WHEREAS, the City of Atlanta is in need of acceptable engineering and construction documents in order to comply with the schedule set forth by the Georgia Department of Transportation (GDOT) for construction of Roxboro Road Underpass; and**

**WHEREAS, due to the unforeseen changes in the original scope of services for the Roxboro Road Underpass project an increase in cost is necessary; and**

**WHEREAS, Norfolk Southern Corporation has agreed to provide the necessary complete plans and specifications needed for the replacement of Roxboro Road Underpass;**

**WHEREAS, the Department of Public Works wishes to provide funding for Roxboro Road Underpass in the amount of \$204,434.00; and**

**WHEREAS, funds are available in the 2002 Reserve Designated D.I.F.Admin. Transportation fund, which may be used at this time.**

**WHEREAS, the Bureau of Purchasing and Real Estate has certified Norfolk Southern Corporation as the only company qualified to have the necessary design engineering services for highway/railway projects performed as contemplated by Section 2-1191 of the City Code of Ordinances.**

**NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:**

**SECTION 1: That the Mayor or her designee is authorized to enter into an Agreement with Norfolk Southern, which will provide necessary complete plans and specifications needed for the replacement of Roxboro Road Underpass in an amount not to exceed \$204,434.00. All contracted work shall be charged to and paid from fund, account and center number: 1C28 574001 M22F012992BA.**

**SECTION 2: The agreement authorized by this resolution shall not become binding upon the City until signed by the Mayor and delivered to the contracting party.**
