EXPRESSING THE CITY COUNCIL'S SUPPORT OF THE MAYOR'S INTENT TO SEEK BINDING ARBITRATION TO REALLOCATE THE STATE SALES TAX DISTRIBUTION FORMULA BETWEEN THE CITY OF ATLANTA AND FULTON COUNTY SHOULD AN EQUITABLE AGREEMENT NOT BE REACHED; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta, Fulton County ("the County") and other municipalities within the County were authorized by referendum election held on November 30, 1982 to levy a joint local option sales and use tax; and

WHEREAS, the proceeds of the tax are currently distributed according to a certificate of distribution executed by the County and the municipalities; and

WHEREAS, the city does not agree that the sales tax allocation formula provides for an equitable distribution of sales tax collections between it and Fulton County; and

WHEREAS, Fulton County has not agreed to a revision to the allocations of sales tax collections; and

WHEREAS, the Mayor is presently involved in good faith negotiations with Fulton County and the State of Georgia; and

WHEREAS, the City of Atlanta wishes to submit to binding arbitration in the event that an agreement cannot be reached.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Council hereby supports the Mayor in the submission of the distribution formula between the City of Atlanta and Fulton County to binding arbitration should an equitable agreement not be reached.

BE IT FINALLY RESOLVED that all resolutions in conflict herewith are hereby repealed.
