AN ORDINANCE BY COMMITTEE ON COUNCIL

AN ORDINANCE TO AMEND THE 2001 CITY OF ATLANTA PRECINCT AND POLLING PLACE ORDINANCE IN PRECINCTS 1G, 2F, 2H, 3C, 3S, 5E, 6D, 6F, 7C, 7E1, 7E2, 7G, 7H, 7L, 8D, 8E, 8S & 10E, AND FOR OTHER PURPOSES.

WHEREAS, the 2001 Precinct and Polling Place Ordinance, dated October 24, 2001, was adopted November 5, 2001, and;

WHEREAS, such Precinct and Polling Place Ordinance has previously been amended by action of the City Council on May 20, 2002 and July 15, 2002, and;

WHEREAS, the Fulton County Board of Registrations and Elections or the DeKalb County Office of Voter Registration and Elections has authorized and approved the temporary relocation of several polling places within the City of Atlanta primarily due to ongoing renovations of the permanent polling places;

WHEREAS, those changes are to precincts/polling places 1G, 2F, 2H, 3C, 3S, 5E, 6D, 6F, 7C, 7E1, 7E2, 7G, 7H, 7L, 8D, 8E, 8S & 10E, and;

WHEREAS, several of these changes have been made on an emergency basis as authorized by Section 21-2-265 of the Georgia Election Code and Rules of the State Election Board, and;

WHEREAS, all affected voters will be notified of these changes by the Fulton County Office of Registrations and Elections or by the DeKalb County Office of Voter Registration and Elections, accordingly, and;

WHEREAS, the governing authority of the City of Atlanta, the Atlanta City Council believes that ratification of these previously authorized changes should be made by this Body.

NOW THEREFORE BE IT ORDAINED that the Atlanta City Council does hereby ratify the previous authorization and approval by the Fulton County Board of Registrations and Elections or the DeKalb County Office of Voter Registration and Elections of precincts and polling places 1G, 2F, 2H, 3C, 3S, 5E, 6D, 6F, 7C, 7E1, 7E2, 7G, 7H, 7L, 8D, 8E, 8S & 10E, within the City of Atlanta.

BE IT FURTHER ORDAINED that the Atlanta City Council does hereby Amend the 2001 Precinct and Polling Place Ordinance, dated October 24, 2001, and Adopted November 5, 2001 which was codified as Section 66-2 of the City of Atlanta Code of Ordinances and adopted by reference, by adding the recent changes to precincts and polling places 1G, 2F, 2H, 3C, 3S, 5E, 6D, 6F, 7C, 7E1, 7E2, 7G, 7H, 7L, 8D, 8E, 8S & 10E, all of which are incorporated into the August 19, 2002 Revision to the 2001 Precinct and Polling Place Ordinance identified as Attachment I to this ordinance with each particular change described by the further attachments identified as Exhibits A through K, all being made a part hereof and noted as follows:



- SECTION 1:** To amend Precinct/Polling Place 1G, currently located at Ralph McGill Elementary School, 760 Martin Street, S.E., by temporarily relocating said precinct to D.H. Stanton Elementary School, due to ongoing renovations at Ralph McGill Elementary School, as indicated by attachment identified as Exhibit A.
- SECTION 2:** To amend Precinct/Polling Place 2F, located at Druid Hills Baptist Church, 1085 Ponce De Leon Avenue, by splitting said precinct with Precinct/Polling Place 2H, also located at Druid Hills Baptist Church, due to the lack of a better location for 2H which was created due to reapportionment, as indicated by attachment identified as Exhibit B.
- SECTION 3:** To amend Precinct/Polling Place 3C, currently located at Anderson Park Recreation Center, 120 Anderson Avenue, N.W., by temporarily relocating said precinct to Turner Middle School, 98 Anderson Avenue, due to ongoing renovations at Anderson Park, as indicated by attachment identified as Exhibit C.
- SECTION 4:** To amend Precinct/Polling Place 3S, currently located at Frederick Douglas High School, 225 Hamilton E. Holmes Dr., N.W., by temporarily relocating said precinct to First Missionary Baptist Church 312 Hamilton E. Holmes Dr., due to ongoing renovations at Frederick Douglas High School, as indicated by attachment identified as Exhibit D.
- SECTION 5:** To amend Precinct/Polling Place 5E, currently located at Holy Temple Baptist Church, 1206 Metropolitan Avenue, S.E., by relocating said precinct to First Iconium Baptist Church 542 Moreland Avenue, S.E., due to repeated break-ins and various other difficulties at Holy Temple Baptist.
- SECTION 6:** To amend Precinct/Polling Place 6F, currently located at Druid Hills Presbyterian Church, 1026 Ponce De Leon Avenue, N.E., by relocating said precinct to Ponce De Leon Public Library, 980 Ponce De Leon Avenue., N.E., due to the management of Druid Hills Presbyterian indicating that their facility is no longer available for use, as indicated by attachment identified as Exhibit E.
- SECTION 7:** To amend Precinct/Polling Places 7E1, 7E2, & 7H, all currently located at 2nd Ponce De Leon Baptist Church, Family Life Center, 2715 Peachtree Road, N.E., by making Precincts 7E1 and 7E2 a joint precinct with Precinct/Polling Place 6D, currently located at Morningside Baptist Church, 1700 Piedmont Road, N.E. Precincts 7E1 & 7E2 will be located in the Gym of Morningside Baptist Church with 6D remaining located in the Church, and Precinct/Polling Place 7H will remain located at 2nd Ponce De Leon Baptist Church, Family Life Center, as indicated by attachment identified as Exhibit F.



SECTION 8: To amend Precinct/Polling Place 7G, currently located at Atlanta International School, 2890 North Fulton Dr., N.E., by relocating said precinct to Fire Station No. 21, 3201 Roswell Rd., N.E., due to the former location at the Atlanta International School no longer being available for use, as indicated by attachment identified as Exhibit G.

SECTION 9: To amend Precinct/Polling Place 7L, currently located at Peachtree Road Lutheran Church, by relocating said precinct to Wieuca Road Baptist Church, 3626 Peachtree Rd., N.E., due to creation of said precinct from Precinct/Polling Place 7C and the need to find a location separate from Precinct 7C, as indicated by attachment identified as Exhibit H.

SECTION 10: To amend Precinct/Polling Place 8D, currently located at Trinity Presbyterian Church, 3003 Howell Mill Road, N.W., by relocating said precinct to Northside Library, 3295 Northside Parkway, N.W., due to the closer location of the library to voters in Precinct 8D, as indicated by attachment identified as Exhibit I.

SECTION 11: To amend Precinct/Polling Place 8E, currently located at Margaret Mitchell Elementary School, 2845 Margaret Mitchell Dr., N.W., by making said precinct a split precinct with Precinct/Polling Place 8S, created due to reapportionment, as indicated by attachment identified as Exhibit J.

SECTION 12 To amend Precinct/Polling Place 10E, currently located at Harper-Archer High School, 3399 Collier Drive, N.W., by temporarily relocating said precinct to Jackson Memorial Baptist Church, 534 Fairburn Road, N.W., due to ongoing renovations at Harper-Archer High School, as indicated by attachment identified as Exhibit K.

SECTION 13. That all ordinances and parts of ordinances in conflict herewith are hereby repealed.

SECTION 8: To amend Precinct/Polling Place 7G, currently located at Atlanta International School, 2890 North Fulton Dr., N.E., by relocating said precinct to Fire Station No. 21, 3201 Roswell Rd., N.E., due to the former location at the Atlanta International School no longer being available for use, as indicated by attachment identified as Exhibit G.

SECTION 9: To amend Precinct/Polling Place 7L, currently located at Peachtree Road Lutheran Church, by relocating said precinct to Wieuca Road Baptist Church, 3626 Peachtree Rd., N.E., due to creation of said precinct from Precinct/Polling Place 7C and the need to find a location separate from Precinct 7C, as indicated by attachment identified as Exhibit H.

SECTION 10: To amend Precinct/Polling Place 8D, currently located at Trinity Presbyterian Church, 3003 Howell Mill Road, N.W., by relocating said precinct to Northside Library, 3295 Northside Parkway, N.W., due to the closer location of the library to voters in Precinct 8D, as indicated by attachment identified as Exhibit I.

SECTION 11: To amend Precinct/Polling Place 8E, currently located at Margaret Mitchell Elementary School, 2845 Margaret Mitchell Dr., N.W., by making said precinct a split precinct with Precinct/Polling Place 8S, created due to reapportionment, as indicated by attachment identified as Exhibit J.

SECTION 12 To amend Precinct/Polling Place 10E, currently located at Harper-Archer High School, 3399 Collier Drive, N.W., by temporarily relocating said precinct to Jackson Memorial Baptist Church, 534 Fairburn Road, N.W., due to ongoing renovations at Harper-Archer High School, as indicated by attachment identified as Exhibit K.

SECTION 13. That all ordinances and parts of ordinances in conflict herewith are hereby repealed.
