Lynn Cobb is manager of the Keep Georgia Beautiful Program, the first certified Keep America Beautiful state affiliate. The Keep Georgia Beautiful Program is housed in the Georgia Department of Community Affairs and its mission is to build and sustain community environmental activities and behaviors, resulting in a more beautiful Georgia.

In her present position, Lynn coordinates statewide events and programs such as the Keep Georgia Beautiful Awards Program, Christmas Tree Recycling, The Great American Clean-Up Campaign in Georgia, and training workshops for educators and business leaders. Lynn currently serves as President of the national organization, Clean State Leaders Incorporated, serves on the national board of directors for Keep America Beautiful, Inc. and serves on the state advisory board for Georgia Adopt-A-Stream. She is a graduate of the Solid Waste Association of North America Landfill Operator's Certification Course.

Prior to acquiring her staff position, Lynn actively served as a volunteer on the Governor's Citizens Advisory Committee for Georgia Clean and Beautiful from 1978 until 1990. She assisted in establishing the Covington/Newton County Clean and Beautiful Program and served as its chairman for four years. Professionally, Lynn served as Corporate Secretary for APCO Graphics, an architectural signage firm.

She is a native of Atlanta, received her formal education from Florida State University in Tallahassee, and has two terrific sons.
