



**A SUBSTITUTE ORDINANCE BY:

AN ORDINANCE AMENDING THE 2002 JOB TRAINING GRANT BUDGET BY ANTICIPATING AND APPROPRIATING \$446,097.00 IN THE WORKFORCE INVESTMENT ACT (WIA) ADULT FUNDS; ANTICIPATING AND APPROPRIATING \$219,950 IN WORKFORCE INVESTMENT ACT (WIA) DISLOCATED WORKERS FUNDS.

WHEREAS, the City of Atlanta administers WIA programs under contract to the Atlanta Workforce Development Agency and the City provides staff listed in the Unclassified Service needed to operate WIA programs for City residents; and

WHEREAS, the AWDA has received a grant award for its Adult allocation of \$446,097.00 for Program Year 2002 (beginning July 1, 2002); and

WHEREAS, the AWDA has received a grant award for its Dislocated Workers allocation of \$219,950.00 for Program Year 2002 (beginning July 1, 2002); and

WHEREAS, the Budget Commission of the City of Atlanta anticipates increasing receipts in the Trust Fund by \$446,097.00 in Adult funds and \$219,950.00 in Dislocated Worker funds;

THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA AS FOLLOWS:

SECTION 1: That the 2000 WIA Adult Trust Fund be and hereby is amended as follows:
