W.**, from the "Single-Family" land use designation to the "Low Density Commercial" land use designation, and for other purposes.

All that tract or parcels of land lying and being in *Land Lot 184 of the 14th District of Fulton County, Georgia*. Said property is more specifically shown on the attached map, Exhibit 'A', which is hereby made a part of this ordinance.

SECTION 2. That the amendments contained herein shall be incorporated into the 2003 CDP printed document.

SECTION 3. That all ordinances or parts of ordinances that are in conflict with this ordinance are hereby repealed.


