

AN ORDINANCE

An Ordinance to amend Section 2-1105(b) of the Code of Ordinances of the City of Atlanta, so as to require that all persons, organizations/entities which operate, oversee or otherwise manage, city-owned facilities or properties, under contract with the City, adhere to the rules, regulations and the operational procedures of the City's Purchasing Code.

WHEREAS, the City of Atlanta has adopted procedures for its exercise of contracting and procurement; and

WHEREAS, such procedures are necessary for the orderly process of procuring goods and services and expending public funds; and

WHEREAS, the City, through its various grant programs and other agencies which have been created, often provide funding for various programs and projects; and

WHEREAS, the Council of the City of Atlanta is desirous of having these agencies adhere to the City's purchasing procedures.

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA,** as follows:

Section 1: That Section 2-1105(b) of the Code of Ordinances of the City of Atlanta which reads:

- (b) Application to city procurements and real estate transactions. This article shall apply to every expenditure of public funds irrespective of their source. It shall apply to the disposal of city supplies, as provided in division 8 of this article pertaining to supply management and to the disposal of city real property, as provided in division 14, subdivision III of this article pertaining to sale and disposition of real estate. Nothing in this article shall prevent any public agency from complying with the terms and conditions of any grant, gift, donation or bequest which are otherwise consistent with law and the operational procedures promulgated by the purchasing agent as authorized in division 17.

**BE AMENDED TO ADD A NEW PARAGRAPH TO READ:**

**All persons, organizations/entities which operate, oversee or otherwise manage, city-owned facilities or properties, under contract with the City shall adhere to the rules, regulations and the operational procedures of the City's Purchasing Code.**

Section 2: That all ordinances and parts of ordinances in conflict herewith are hereby repealed.
