**AN ORDINANCE BY COUNCILMEMBER CLAIR MULLER
AS SUBSTITUTED BY FINANCE/EXECUTIVE COMMITTEE**

**AN ORDINANCE TO AMEND SECTIONS
138-201, 138-202, 138-203 AND 138-205 OF
THE OUTDOOR FESTIVAL ORDINANCE TO
PROVIDE FOR ADDITIONAL PERMIT
REQUIREMENTS FOR MUNICIPAL SERVICES
FOR FESTIVAL ORGANIZERS.**

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE ATLANTA, GEORGIA
THAT Sections 138-201, 138-202, 138-203, and 138-205 of the City Code of Ordinances shall be amended
to reflect the following changes:

Section 138-201 APPLICATION

- Change 60 days to 90 days prior to event
- (4) add to "specific location" the name of Civic Association and the NPU where the festival will be held and the requirements that both be notified for recommendation for approval or disapproval of the festival application
- (15) add the requirement for a specific plan for external security, including the impact to the zone, a plan for parking control and traffic control and payment to the city for extra personnel hours
- (14) add requirement for a cleanup plan for the larger area surrounding the specific location of the festival, an estimate of extra personnel hours for city workers and payment to the City

Section 138-202 REVIEW OF APPLICATION

- add requirement that completed application be forwarded to the affected neighborhood civic association and upon recommendation of approval by the affected neighborhood civic association, then forwarded to the affected NPU

Section 138-203 CRITERIA FOR GRANT OF PERMIT

- (8) add that chief of staff MUST require payment of arrears for previous festivals

Section 138-205 PERMIT FEES

- (b) Class A permit
 - Permit fee \$12,000
 - Sanitation fee \$1,000
- Class B permit
 - Permit fee \$4,000
 - Sanitation fee \$600
- Class C permit
 - Permit fee \$2,000
 - Sanitation fee \$300
- Class D permit
 - Permit fee \$1000
 - Sanitation fee \$150
- Class E permit
 - Permit fee \$150
 - Sanitation fee \$40
