AMENDING THE 2002 (PARK IMPROVEMENT FUND) BUDGET, SO AS TO TRANSFER APPROPRIATIONS IN THE AMOUNT OF \$352,156.71 TO ANDERSON PARK RECREATION CENTER IMPROVEMENTS; LANG CARSON PARK RECREATION CENTER IMPROVEMENTS; AND THE BROWNWOOD PARK RECREATION CENTER IMPROVEMENTS ACCOUNT IDENTIFIED AS CONSTRUCTION OF BUILDINGS CITYWIDE, ACCOUNT NUMBER 1C22 773001 N12D09B69999 ON BEHALF OF THE DEPARTMENT OF PARKS, RECREATION AND CULTURAL AFFAIRS; AND FOR OTHER PURPOSES.

Whereas, the City of Atlanta, Department of Parks, Recreation and Cultural Affairs owns and operates the system for parks and recreational facilities for the citizens of the City of Atlanta to enjoy; and

Whereas, the Department of Parks, Recreation and Cultural Affairs has started construction projects for the purpose of making additions to and improving existing recreational centers; and

Whereas, due to unforeseen conditions, as well as, changes within the scope of work for these construction projects at the Anderson Park Recreation Center; Lang Carson Park Recreation Center; and the Brownwood Park Recreation Center, additional funding is required in the furtherance of these construction projects.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:
