**A RESOLUTION AUTHORIZING THE MAYOR TO DECLARE
NOVEMBER 1ST OF EACH CALENDAR YEAR HOMELESS
PERSONS MEMORIAL DAY IN THE CITY OF ATLANTA; AND
FOR OTHER PURPOSES.**

WHEREAS, between 48,000 and 68,000 individuals experience homelessness
for at least one night during the year in Atlanta; and

WHEREAS, at least 2,000 individuals are forced to sleep in the streets, cars, and
abandoned buildings of the City of Atlanta each night; and

WHEREAS, 63 homeless individuals, many of whom were women and children
died in the city of Atlanta last year; and

WHEREAS, The Task Force for the Homeless has commemorated the lives and
deaths of hundreds of homeless individuals in the City of Atlanta for the past fourteen
years.

NOW THEREFORE BE IT RESOLVED that the City Council of Atlanta,
Georgia hereby declares November 1st of each calendar year "Homeless Persons
Memorial Day" in the City of Atlanta.

In purveyance of this Resolution, be it resolved by the City Council of Atlanta, Georgia
that the declaration of this resolution to the citizens of the City of Atlanta occur at the
homelessness awareness event hosted by the Task Force for the Homeless in conjunction
with many other Atlanta organizations at Woodruff Park each year on November 1st.
