AN ORDINANCE AMENDING SECTION  
2-813(b) AND SECTION 2-814(B) OF CHAPTER 2,  
OF THE CITY CODE OF ORDINANCES  
ENTITLED "STANDARDS OF CONDUCT".

Whereas, the City of Atlanta has recently adopted a new Chapter 2, entitled "Standards of Conduct"; and

Whereas, the research work is still ongoing for improvements to the City's Ethics Code; and

Whereas, disclosure requirements should be added for other categories of people doing business with the City or lobbying to do business with the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That Section 2-813(b) and Section 2-814(b) of the City Code of Ordinances, Chapter 2 entitled "Standards of Conduct" be amended so as to include lobbyists registered with the City of Atlanta as being required to file a financial disclosure at the same that elected officials and employees file.

SECTION 2: That all ordinances and parts of ordinances in conflict herewith be hereby repealed.
