AMENDED BY FULL COUNCIL

AN ORDINANCE TO REIMBURSE BUILDING PERMIT
FEES FOR HOMEOWNERS WHOSE RESIDENCES
WERE FLOODED ON SEPTEMBER 21, 2002; AND FOR
OTHER PURPOSES.

WHEREAS, on September 21, 2002, a major rainstorm event occurred in the City of Atlanta and caused significant damage to certain single family, owner occupied dwellings; and

WHEREAS, building permits and related fees are required for the repairs of such flood-damaged structures, and

WHEREAS, the City recognizes the need to assist such single family homes owners in this regard by including such cost in the 2002 Flood Disaster Relief Fund,

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA AS FOLLOWS:

SECTION 1: That the owner of occupied single family dwellings identified in the attached Exhibit A, shall be reimbursed from the 2002 Flood Disaster Relief Fund for the payment of building, electrical, plumbing, and hvac permit fees required for the repairs only, not the total reconstruction of flood damage that occurred on September 21, 2002, for the time period of September 21, 2002, to November 30, 2002.

SECTION 2: That owner occupied single family dwelling occupants who may have paid for such permits referenced above may be reimbursed similarly for such fees from the 2002 Flood Disaster Relief Fund. Such requests shall be in writing by presenting copies of paid permits and shall be approved by the Director of the Bureau of Buildings and the Department of Finance.

SECTION 3: That all ordinances in conflict herewith are hereby repealed.


