**An Ordinance by Councilmembers Jim Maddox, Ceasar Mitchell, H. Lamar Willis & Cleta Winslow As Substituted by Finance/Executive Committee & Amended by Full Council**

An Ordinance to amend Chapter Two of the Code of Ordinances Of the City of Atlanta so as to waive Sections 2-221(b) and 2-251 of the Code of Ordinances for this instance only; to provide for the appointment of Mr. Adam L. Smith as Chief Procurement Officer; and for other purposes

**Whereas**, the City of Atlanta desires to recruit and retain the most qualified individuals as department, bureau of office heads; and

**Whereas**, the recruitment and retention of such outstanding individuals require diligent search and consideration; and

**Whereas**, the Council and the Mayor wish to promulgate rules and standards that encourage the most innovative and qualified persons to seek careers in City government.

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA** as follows:

**Section 1:** That Chapter Two, Section 2-221(b) which reads:

"(b) The Council may prescribe by ordinance additional specification qualifications for each official who is the head of a department, bureau or office."

**The above section shall be waived for this instance only to provide for the appointment of Mr. Adam L. Smith as Chief Procurement Officer in accordance with 02-C-1899.**

**Section 2:** That Chapter Two, Section 2-251, of the Code of Ordinances which reads as follows:

"Section 2-251 Additional qualifications of the Chief Procurement Officer.

In addition to the general qualifications specified in Section 2-221, the Chief Procurement Officer shall possess a master's degree in business administration, public administration or marketing; five years prior experience as a Chief Procurement Officer or a Deputy Chief Procurement Officer in a contraction or procurement system



of comparable size and scope. The requirement of a master's degree may be substituted by a bachelor's degree in the same field(s), plus ten (10) years managerial experience in public or corporate purchasing operations, marketing, or contract administration"

**The above section shall be waived for this instance only to provide for the appointment of Mr. Adam L. Smith as Chief Procurement Officer in accordance with 02-C-1899.**

**Section 3:** To the extent any ordinances, or parts of ordinances found elsewhere in this Code of Ordinances are in conflict herewith, it is the intent of that Section 2-221 shall prevail.
