SCHEDULING A PUBLIC HEARING IN CONNECTION WITH THE PROPOSED ADOPTION OF THE NORTHWEST ATLANTA REDEVELOPMENT PLAN AND CREATION OF TAX ALLOCATION DISTRICT NUMBER THREE – PERRY/BOLTON; TO ESTABLISH THE PURPOSE OF SAID PUBLIC HEARING; TO DIRECT THE MUNICIPAL CLERK TO ADVERTISE THE PUBLIC HEARING AND THE COUNCIL MEETING AT WHICH THE REDEVELOPMENT PLAN WILL BE CONSIDERED FOR ADOPTION; AND FOR OTHER PURPOSES.


WHEREAS, the City of Atlanta has proposed to adopt the Northwest Atlanta Redevelopment Plan and create Tax Allocation District Number Three – Perry/Bolton; and

WHEREAS, the Redevelopment Powers Law requires that the Council hold at least one public hearing on the redevelopment plan and provides that the Council shall cause the time, date, place, and purpose of each such public hearing to be advertised in one or more newspapers of general circulation at least once during a period of five days immediately preceding the date of each public hearing; and

WHEREAS, the Redevelopment Powers Law also requires that the Council meeting at which the Redevelopment Plan is to be considered be so advertised; and

WHEREAS, the Council of the City of Atlanta intends to hold said public hearings in accordance with the applicable provisions of State law.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA
HEREBY RESOLVES as follows:



SECTION 1. A public hearing is hereby scheduled to be held before the Community Development/Human Resources Committee of the City Council on Tuesday, November 26, 2002, at 1:00 p.m. in Committee Room 2 located on the second floor of the City Hall Annex, 55 Trinity Avenue, S.W., Atlanta, Georgia.


SECTION 2. The purpose of said public hearing is to seek public comment regarding Resolution 02-R-_____ which proposes adoption of the Northwest Atlanta Redevelopment Plan and creation of Tax Allocation District Number Three – Perry/Bolton.




