**AN ORDINANCE TO AMEND ARTICLE "V",
CLASSIFICATION PLAN, SECTION 114-477, OF
THE CODE OF ORDINANCES, CITY OF
ATLANTA, GEORGIA, SO AS TO ABOLISH
VACANT POSITIONS (PART A), ABOLISH
FILLED POSITIONS (PART B), CREATE,
RECLASSIFY, TRANSFER, SALARY AND GRADE
ADJUST POSITIONS (PART C), ADOPT
PERSONNEL POLICY AMENDMENTS AND NEW
INITIATIVES (PART D), IN SUPPORT OF THE
2003 BUDGET; AND FOR OTHER PURPOSES.**

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS that Section 114-477, of the Code of Ordinances, City of Atlanta, Georgia, be and the same is hereby amended as follows:







[PART D: PERSONNEL POLICY AMENDMENTS AND NEW INITIATIVES

SECTION 1 - MAYOR'S SALARY 2003: That as a further contribution to offset the 2003 budget deficit, the Mayor shall decline to accept \$40,000 of her annual salary. To accomplish this savings the Mayor shall accept 73.5 furlough days in 2003. The Chief Financial Officer is hereby directed and authorized to withhold the equivalent amount, pro rata, between January 1, 2003 and December 31, 2003.

SECTION 2 - SALARY INCREMENTS 2003: That the annual salary increment as provided in Section 114-126 is hereby suspended for 2003 only.

The provisions of this section shall not apply to employees of the Atlanta/Fulton County Water Resource Commission.

SECTION 3 - CITY MINIMUM WAGE: That the City of Atlanta shall hereby establish a minimum annual salary of \$22,000 for all permanent full-time employees, effective the first pay period of the 2003 budget. That the classification salary schedule for 40 hour per week employees shall be modified as indicated below:

- Classifications allocated to Salary Grades 1 – 6 are hereby adjusted to Salary Grade 7.
- Employees earning less than \$22,000 in Salary Grades 1 – 6 are hereby adjusted to Salary Grade 7 Step 1.
- Employees in Salary Grades 1 – 7 earning at least \$22,000 are hereby adjusted to Salary Grade 7 Step 2.

SECTION 4 - DEPARTMENT OF HUMAN RESOURCES RESTRUCTURING: That classified employees in the Department of Human Resources shall be given priority consideration for newly created classified positions within the department. Said priority consideration shall be implemented in accordance with the RIF procedures set forth in City Code Section 114-379. In the event a classified employee is not selected for a classified position in the department, said employee shall be placed in the larger citywide RIF Pool with continued priority consideration for a classified position in the department.

SECTION 5 - POSITIONS RECLASSIFIED OR GRADE ADJUSTED TO SALARY GRADE 19 AND ABOVE: That all classified filled positions and permanent incumbents which are reclassified or grade adjusted to Salary Grade 19 and above shall become unclassified. Incumbents, reclassified or grade adjusted with said positions, shall be eligible for a name clearing hearing before the Civil Service Board, if subject to adverse action, provided the incumbent was in a classified status immediately prior to the reclassification or grade adjustment.

SECTION 6 – FURLOUGH OF MUNICIPAL COURT EMPLOYEES: That all Municipal Court employees not included in Part C, Section 8, Defunding Unclassified Positions with Incumbents, be furloughed two days each month to meet required budgetary reduction.

SECTION 7 - DHR AUTHORIZED TO CORRECT ERRORS: That the Department of Human Resources is authorized to made administrative corrections to the position information contained in this ordinance as necessary, provided that no correction increases the costs approved by this ordinance.

SECTION 8: That all ordinances and parts of ordinances in conflict herewith be and the same are hereby waived.
