



AN ORDINANCE BY

COUNCIL MEMBER CLAIR MULLER

AMENDING THE 2003 (1999 AND 2001
WATER AND WASTEWATER BOND FUNDS)
BUDGETS IN THE AMOUNT OF SEVENTY
FOUR MILLION SIXTY ONE THOUSAND
DOLLARS (\$74,061,000.00) TO FUND THE
WEST AREA CSO STORAGE TUNNEL AND
FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta owns and operates a wastewater collection and treatment system; and

WHEREAS, the City has entered into a consent decree that requires certain improvements be made to the collection and treatment systems by the dates specified in the consent decree; and

WHEREAS, the West Area Combine Sewer Overflow Remediation Plan, as required by the consent decree, will collect partially treated CSO from the Clear Creek, Tanyard Creek and North Avenue CSO Treatment facilities, provide storage for up to 150 million gallons and transport the stored overflows to a new CSO treatment facility for discharge of treated effluent to the Chattahoochee River; and

WHEREAS, sufficient funding is needed to purchase the land, easements and for the construction of the West Area CSO Tunnel.

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, as follows:
