AN ORDINANCE

AUTHORIZING THE CREATION OF A TRUST FUND FOR THE RECEIPT OF PRIVATE DONATIONS FOR THE PURPOSE OF IMPROVING THE BUILDING PERMITTING PROCESS ; TO ACCEPT DONATIONS; AND FOR OTHER PURPOSES.

WHEREAS, the Atlanta Chamber of Commerce has expressed an interest assisting the City in making technology improvements in the Building Permitting process; and

WHEREAS, the City of Atlanta is authorized to receive any donations or gifts of real or personal property which may be made to it by deed or gift, will or otherwise; and

WHEREAS, the establishment of a revenue fund account center is necessary for receipt and disbursement of these funds.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: The City is authorized to accept donations to be used for software purchase or maintenance, professional service, and equipment for improvements in the Building Permitting process.

Section 2: The Chief Financial Officer is thereby authorized to establish an account to be restricted and designated as a Trust Fund for improvements to the Building Permitting process into which any and all donations so designated shall be deposited into fund account center 3P02 464101 Y11T2001QNA0 and funds shall be charged and paid from fund account center 3P02 5***** Y11T2001QNA0.
