A RESOLUTION BY THE ATLANTA CITY COUNCIL TO PLACE A
REQUEST FOR AN EXEMPTION FROM SCHOOL TAXES FOR
ATLANTA CITIZENS 62 YEARS OF AGE OR OVER ON THE CITY OF
ATLANTA 2004 LEGISLATIVE PACKAGE FOR THE GEORGIA
GENERAL ASSEMBLY; AND FOR OTHER PURPOSES.

WHEREAS, many City of Atlanta residents 62 years of age or over live off of fixed incomes; and

WHEREAS, City of Atlanta citizens 62 years of age or over deserve some tax relief in their retirement years; and

WHEREAS, school taxes represent a potentially substantial burden to senior citizens; and

WHEREAS, other counties throughout the Atlanta Metropolitan area and the State of Georgia have enacted programs to exempt citizens 62 years of age or older from school taxes; and

WHEREAS, the City of Atlanta should provide an exemption from school taxes for residents age 62 years or older.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF ATLANTA GEORGIA, as follows:

SECTION 1: That the 2004 City of Atlanta Legislative Package should be amended to include a request that the Fulton County Delegation conduct a study, hold public hearings, and the exact the exemption from school taxes for Atlanta citizens 62 years of age and over.

SECTION 2: That all ordinances or resolutions, or parts thereof, in conflict herewith, are hereby repealed.
