**A RESOLUTION BY THE ATLANTA CITY COUNCIL TO INCLUDE IN THE 2004 CITY LEGISLATIVE PACKAGE A REQUEST TO THE FULTON COUNTY DELEGATION TO THE GEORGIA GENERAL ASSEMBLY TO INCLUDE LEGISLATION AUTHORIZING THE CITY OF ATLANTA TO ACCESS AND UTILIZE APPROXIMATELY \$20,000,000 PAID TO THE ENVIRONMENTAL PROTECTION DIVISION SINCE 1990 FOR VIOLATIONS OF STATE ENVIRONMENTAL PROTECTION LAWS.**

**WHEREAS**, the City is in the midst of upgrading its water and sewer infrastructure to meet Consent Decree and other infrastructure construction requirements; and

**WHEREAS**, since 1990, the City has paid approximately \$20,000,000 in fines to the State for violations of State environmental protection laws; and

**WHEREAS**, upgrades to the City water and sewer infrastructure will cost several \$Billion; and

**WHEREAS**, the monies paid to the State for these fines should be used to ameliorate the problems that caused the fines in the beginning.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, that the city legislative package include a request to the Fulton County Delegation to the Georgia General Assembly to include legislation authorizing the City of Atlanta to access and utilize approximately \$20,000,000 paid to the environmental protection division since 1990 for violations to State environmental protection laws.
