A RESOLUTION TO INCLUDE IN THE ATLANTA/FULTON COUNTY 2004 LEGISLATIVE PACKAGE A REQUEST THAT THE 2004 GEORGIA GENERAL ASSEMBLY AMEND THE GEORGIA ELECTION CODE TO REQUIRE THAT AN INDEPENDENT SCHOOL DISTRICT PAY THE COST OF CONDUCTING ITS ELECTIONS.


WHEREAS, State law currently requires that the municipality in which an independent school system is located conduct and pay for elections for the school system; and

WHEREAS, this results in burdening municipalities with undue administrative costs; and

WHEREAS, a change in the State Elections Code requiring independent school systems to pay for their own elections would free municipalities from this burdensome responsibility.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Atlanta/Fulton County 2004 Legislative Package include a request that the GEORGIA ELECTION CODE be amended to require that independent school districts pay the cost of conducting its elections
