**AN ORDINANCE AMENDING THE 2003 (2001 BOND PROJECT  
FUND) BUDGET IN THE AMOUNT OF \$136,400.00 FOR

WHEREAS, "Intersection Signals, Council District 7" was not funded in the first bond  
issue of the Quality of Life program, and

WHEREAS, funds are available in the Restricted Reserve of 2001 Bond Project Fund
