**AN ORDINANCE AMENDING THE 2001 QUALITY OF LIFE BOND
FUND BUDGET DEPARTMENT OF PLANNING AND COMMUNITY
DEVELOPMENT BY TRANSFERRING BETWEEN ACCOUNTS \$184,895
FOR THE PURPOSE OF ACQUIRING PARCEL NUMBER 14-237-05-013
LOCATED AT 3205 MARTIN LUTHER KING JR. DRIVE S.W. FOR THE
EXPANSION OF ADAMSVILLE PARK AND GYMNASIUM PROPERTY;
AND FOR OTHER PURPOSES**

WHEREAS, the Adamsville Park Gymnasium and park facility has entered final stages of completion; and

WHEREAS, the City of Atlanta's Bureau of Parks and Recreation has negotiated with the owners of property parcels bordering the project on Martin Luther King Jr. Drive S.W. for the expansion of greenspace associated with this important community addition; and

WHEREAS, ordinance number 02-O-1256 adopted by the Council of the City of Atlanta, Georgia on July 15, 2002, and approved by the Mayor on July 22, 2002, authorized the acquisition of three parcels located at 3205, 3211, and 3221 Martin Luther King, Jr. Drive, S.W.; and

WHEREAS, parcel number 14-237-05-033 located on the front portion of 3211 Martin Luther King, Jr. Drive S.W. has been acquired; and

WHEREAS, the property located at parcel number 14-237-05-013, at 3205 Martin Luther King Jr. Drive S.W. was duly negotiated at price satisfactory to the City of Atlanta and the current owner of the property; and

WHEREAS, additional funds totaling \$184,895 are needed in order to complete the acquisition and purchase of the subject parcel.



NOW THEREFORE IT IS ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

Section 1: That the 2001 Quality of Life Bond Fund Budget Department of Planning And Community Development is hereby amended as follows:

An Ordinance authorizing the Chief Financial Officer to transfer between Accounts within the 2002 (2001 Public Improvement Bond Funds) Budget \$120,000.00 for the acquisition of two parcels of land for the Adamsville Recreation Center/natorium; amending Ordinance #01-O-1697 by Transferring between accounts \$120,000.00 in funds designated for Greenspace Acquisition at the Adamsville Park site to the Account and Cost Center designated for the Utoy Creek Area Trail and Greenway Corridor and authorizing the Purchasing Agent to enter into an Agreement with Smith Real Estate Services, Inc. to negotiate and Acquire the necessary properties within the project; and for other purposes.

**AN ORDINANCE BY COUNCILMEMBER C.T. MARTIN
AS SUBSTITUTED BY FINANCE/ EXECUTIVE COMMITTEE**

AN ORDINANCE TO TRANSFER THE AMOUNT OF \$120,000, FOR THE PURPOSE OF PROVIDING FUNDS FOR THE ACQUISITION OF REAL PROPERTY AT THE ADAMSVILLE RECREATION CENTER AND NATATORIUM, BETWEEN ACCOUNTS WITHIN THE 2002 (2001 QUALITY OF LIFE BOND FUND) BUDGET; IDENTIFYING SPECIFIC PROPERTIES TO BE TARGETED FOR PURCHASE FOR THE ADAMSVILLE RECREATION CENTER AND NATATORIUM SITE; AUTHORIZING THE PURCHASING AGENT TO ENTER INTO AN AGREEMENT WITH SMITH REAL ESTATE SERVICES, INC. TO NEGOTIATE AND ACQUIRE THE TARGETED PROPERTIES AND TO PAY THE NECESSARY COSTS; AUTHORIZING THE USE OF CONDEMNATION PROCEEDINGS FOR THE TARGETED SITES IF NECESSARY; AUTHORIZING THE PAYMENT OF ASSOCIATED COSTS; AND FOR OTHER PURPOSES.

WHEREAS, Ordinance 01-O-2020 adopted by the Council on December 3, 2001 and approved by the Mayor on December 11, 2001, authorized the Director of the Bureau of Purchasing and Real Estate to negotiate the possible future purchase of three additional properties adjacent to the site of the Adamsville Recreation Center/Natatorium; and

WHEREAS, funds in the amount of \$634,200 were authorized from the 2001 Quality of Life Bond Fund, Park Impact Fees, and were appropriated to cover the cost of such land for the Natatorium; and

WHEREAS, real estate appraisals of two of the adjacent land parcels, authorized for acquisition by ordinance 01-O-2020 reflected the need for an additional \$120,000 over the existing appropriation of \$634,200 in order to secure purchase of these parcels; and

WHEREAS, State of Georgia Greenspace Program Grant Award funds in the amount of \$120,000 were appropriated by Ordinance 01-O-1697 to provide the estimated additional funding requirements; and

WHEREAS, the use of State of Georgia Greenspace Program Grant Award funds is restricted to the preservation of existing greenspaces, and not for expenditure on land parcels holding existing structures for the purpose of creating greenspace; and

WHEREAS, State of Georgia Greenspace Program Grant Award funds appropriated by Ordinance 01-O-1697 can be applied toward purchase of greenspace for the Utoy Creek Area Trail and Greenway Corridor; and



WHEREAS, funds in the amount of \$120,000 would then be available for transfer from the fund, account, center combination designated in the 2001 Quality of Life Bond Fund for the Lionel Hampton Trail project, for transfer to the fund account, center combination designated for the Adamsville Recreation Center/Natatorium project, within the same bond fund; and

WHEREAS, the authorized transaction will provide enough funding to acquire two of the three parcels required in said project.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA AS FOLLOWS:

Section 1: That the 2002 (2001 Quality of Life Bond Fund) Budget is hereby amended as follows:

Section 3: That Section Three of ordinance 01-O-2020 is hereby amended by striking the references therein to the fund account and center numbers to be used for the payment of services and adding fund, account, and center number 1C45 774001 Y63F061992BG as the fund account an center number to be used for the for payment of services and specifying that all charges, including but not limited to surveys, environmental assessments, appraisals, consultant fees, title reports, and other closing costs may be paid from this fund account and center.



Section 4: That the Purchasing Agent in cooperation with Smith Real Estate Services, Inc. (Consultant), is hereby authorized to negotiate with affected property owners and to acquire the necessary real property interest located at 3205 Martin Luther King Jr. Drive, S.W. (14-237-05-013); 3211 Martin Luther King Jr. Drive S.W. (14-237-05-033), and 3221 Martin Luther King Jr. Drive S.W. (14-237-05-034) in the Adamsville Recreation Center/Natatorium Project.

Section 5: That the Purchasing Agent is hereby authorized to obtain surveys, title reports, and appraisals and to establish estimates of just compensation based thereon to be offered property owners in connection with the project.

Section 6: That the requirements of City Code Section 2-1541 (d) of the Procurement and Real Estate Code are waived to allow the purchase of property on behalf of the City without further authorization of City Council.

Section 7: That the City's Consultant is authorized to settle those acquisitions of property at an amount not to exceed ten percent (10%) above the estimated just compensation. The Purchasing Agent is authorized to administratively settle, with appropriate substantiating documentation, e.g. appraisal report, without further authorization of City Council, those acquisitions which exceed the limitations which the City's Consultant cannot otherwise acquire. However, in no event shall the Purchasing Agent's authority to administratively negotiate or settle such acquisitions without Council authorization exceed 20% above the estimated just compensation of affected properties.


Section 8: That if negotiations with the affected property owners fail, the City Attorney is authorized to use all means necessary and within her/his power, up to and including Condemnation to acquire the necessary real property interests; and, the City Attorney is authorized to engage the services of outside counsel, where necessary, to handle Condemnation proceedings and pay for such services without further authorization from City Council.

Section 9: That the City Attorney, or her/his designee, if necessary, is hereby authorized to institute condemnation proceedings pursuant to the appropriate method allowed by applicable law.

Section 10: That the City Attorney, or her/his designee, is hereby authorized to monitor and supervise the closing transactions, performed by Consultants, with affected property owners in the Adamsville Recreation Center/Natatorium Project.


